Flowers, Walter Papers relating to the integration of the University of Alabama, 1955-1958

Background:

Scope and Content: In January of 1956, a black woman named Autherine Lucy registered and began attending classes at the University of Alabama. She was helped by the National Association for the Advancement of Colored People and their local officials working to further equal opportunities and rights in education. This was two years after the United States Supreme Court decision that "Separate but equal" education was inherently unequal. However, some people simply were not ready to face integration. Such was the case of some Alabama students and local residents of Tuscaloosa and the surrounding area. Initially, there were minor signs of protest along with small groups of protestors. But, the protestors grew in number and adamant opinion. By the day of Lucy's second day of class, there were mobs that had resorted to verbal and physical violence. There were violent threats and rocks and eggs thrown toward Lucy as well as others. These episodes of protest and violence hit newspapers all over the United States and the world.

In response to the news of protest and violence, people wrote letters of opinion to the University of Alabama. The letters in this file are largely addressed to the Student Government Association president Walter Flowers. They express a wide variety of opinion, background and knowledge. As is evident in the letters, many people were confused and ignorant about the true facts of the situation. There are letters from both extremes and many points in between. The Archives Department is not sure that the collection is complete with all letters. They are divided into three major boxes which are further divided into the following files: Individuals, Official School Organizations, Students, Teachers, etc. from Other Schools (Personal or Unofficial), Publications, Lone Newspaper Clippings, and Newspaper material. The letters and information are arranged chronologically but most are from February and March of 1956. Those that are undated are at the end of each file. The oversized box contains whole newspapers and individual clippings related to the subject as well as some tabulated data that were included in the collection.
