283.1.2	Oath of Allegiance Certificate, Elliott C. Hannon, dated July 6, 1885; signed by William H Seward, Secretary of State. This is a photostatic copy.

283.1.21	Special Orders form Headquarters, Department of Richmond, only date readable is 1873, which paroles Lt. K. G. Street, until he can be exchanged as a prisoner of war.
283.1.22	Letter, dated April 12, 1861, addressed to "Cousin Jane", from J. C. Celurke; writer gives brief summation of secessionist sentiment in Virginia and discusses the feelings between North and South.

283.1.27	Letters, Jesse McQuigg to Miss Sallie Mcquigg, dated February 5, 1863 to July 23, 1865; these letters give insight into the personal agonies of an increasingly dispirited Southerner and some excellent comments on the military aspects of the war; he fought in the Battle for Atlanta, and gives a description of the confederate retreat through Georgia in 1864; he also speculates on the replacement of General Joseph E. Johnston with General John R. Hood on July 7, 1864; the final letter, written after the end of the war, expresses his sorrow in defeat and his personal pessimistic view of the post-war period.

283.6.2	United Confederate Veterans Association membership poster issued to J. M. Johnson, 11 June 1897. Service was in Company E, 13 th Regiment and Freeman's Battery of Forest's Cavalry. Discharged 28 June 1865 as a Private from Point Lookout, Maryland Prison. Encapsulated.
