Sheet Metal Workers Local Union #48 Records

Background: The union was founded on January 25, 1888 in Toledo, Ohio, as the Tin, Sheet Iron and Cornice Workers' International Association. In five years the organization grew to include 108 locals in the United States, including the Birmingham local.

Scope and Content: The papers of Local Union #48 (1903-1982) contains four subdivisions: Local Union #48, the Joint Apprenticeship Committee, Health and Welfare/Pension Fund, and Miscellaneous and Photographs. These subdivisions contain nineteen series.

The collection is incomplete, and the bulk of information is inclusive of 1950-1980. With the exception of incomplete list of administrative personnel (1903-1936), there is no substantial information available on union activity prior to 1948.

The first subdivision, Local Union #48 (1938-1979), contains information related to contractors, building and construction trade councils, union political activity, jurisdictional disputes, the Tennessee Valley Authority, communications with Sheet Metal Workers International Association, and other items.

Additional information is the Records of Negotiation (1939-1981) related to contractual agreements; Records of Membership (1940-1979) consisting of application forms, membership rosters, and obligations.

Financial Records (1935-1979) contain federal and state tax receipts, forms, cancelled checks, limited correspondence, monthly statement/reports, and members' dues receipt books. Additional financial information is related to insurance and business office receipts and to TVA dues check off.

Minutes of Local #48 (1956-1980), although incomplete, reflect union attitude about political events at the national and state level, problems related to membership, election of officers, disposition of finances, and related information.

Publications (1963-1983) contains limited editions of Sheet Metal Workers Journal, Annual Reports of the National Training Fund (198m1), the 32nd General Convention (1966), the 35th General Convention (1978), limited newsletters of the U.S. Department of Labor, the Sheet Metal Workers International Association, the Alabama AFL-CIO, and miscellaneous booklets, including the Constitution and By-Laws of Local #48.

Other items are: a complete set of The Scene Today, a publication of the International Association (2/74-7/81); a Credit Union service guide; two volumes,

National Business Man's Guide of Goods & Services, 1973 and Classified Business Directory, 1972-73.

The second subdivision, the Joint Apprenticeship Committee (JAC) 1948-1979, contains correspondence related to general business within the program, veteran training, civil rights activity, and apprenticeship standards.

Also included are the Articles of Incorporation of the Alabama Sheet Metal Joint Industry Board; Federal Standards and Guidelines for Compliance with Civil Rights Laws. Birmingham Hometown Plan information includes limited correspondence, forms, and Statement of Purpose.

General information related to membership consists of miscellaneous correspondence, indentures, applications, lists of initiates, and items related to banquets and certificate awards.

Financial information related to JAC is incomplete, consisting of check stubs, receipts, statements, etc. inclusive of 1953-1974.

The JAC minutes (1954-1980) contain information on general policy matters, changes in apprenticeship recruiting, adjustments in course requirements, discussion of financial matters, election of officers, and related items.

The third subdivision, Health and Welfare/Pension Fund (1949-1981), contains correspondence related to welfare planning, compliance with Internal Revenue Code, insurance, and related information.

Minutes of the Pension Fund Board of Trustees are very limited, with only 1967 and 1970 represented.

Financial data includes audit reports, 1973-1975; monthly reports, 1975-1976; and investment reports, 1972-1974.

Publications include plans for health and welfare/pension: Plan A, National Pension Fund, 1970, 1974, and 1979; Plan for Local #48, 1975; Local #48 Health and Welfare Fund, 1981; and an Employee Benefits Factbook, 1972.

The fourth subdivision, Miscellaneous and Photographs, contains an assortment of miscellaneous correspondence (1947-1954), booklets on Alabama Labor Department regulations, Committee on Political Education, AFL-CIO Internal Disputes Plan, and credential forms.

Additional information relates to the Tennessee Valley District Council Convention, Muscle Shoals Building and Construction Trades Council, Local #48 property appraisal, a list of officers and building agents (1903-1936), and miscellaneous items.

Also within this subdivision is supplemental material on the National Training Fund and the Birmingham Hometown Plan.

The photographic collection (1913-1975) contains approximately 70 photos related to activities of the Tennessee Valley District Council, Joint Apprenticeship Committee, Widows Creek Steam Plant (TVA) work, Local #48 building construction and dedication, and several photos of unidentified persons.
