GREEN, W. COOPER **Papers, 1938-1954**

Background:

W. Cooper Green was born in Birmingham, Alabama on November 18, 1900. He was a graduate of Birmingham-Southern College and Columbia University. Green worked as a teacher and football coach, and as a real estate and insurance broker before being elected to the Alabama legislature in 1931. In 1933 he was appointed Birmingham's postmaster, and elected president of the Birmingham City Commission, a position that also carried the title "Mayor," in 1940. Green served as mayor until 1953 when he resigned to take a position with Alabama Power Company. He resigned from Alabama Power in 1959 to accept an appointment as president of the Jefferson County Commission, a position he held until 1975.

Green served as president of the Alabama Chapter of the National Association of Postmasters, president of the Alabama League of Municipalities, president of the United States Conference of Mayors, and president of the Association of County Commissioners of Alabama.

Cooper Green died in Birmingham in 1980.

This collection contains the office files generated during Cooper Green's terms as president of the Birmingham City Commission (Mayor). The files include correspondence, memoranda, publications, reports and other material relating to city government.
